UPON hearing counsel the Court made the following
O R D E R

By our Order dated 27th September, 2010, we had directed the two States, viz., States of Andhra Pradesh and Karnataka, to file affidavits indicating the number of projects and the financial costs involved therein within one week.

Today, we have received affidavits from the said two States. As far as State of Andhra Pradesh is concerned, the affidavit seeks two weeks' time to give us up-to-date information about the projects which are in the pipeline.

As regards State of Karnataka, an affidavit has been filed in Court today. We expect the Chief Secretary of the State of Karnataka to give us details of the projects. Those details must explain the particulars which are expected to be filed in the prescribed Formats 'B' and 'D' which have been sent to the State of Karnataka. The affidavit filed by the State of Karnataka does not give any such particulars. It needs to be specifically made clear as to how many projects are awaiting administrative and financial approval, for how long and why? How many projects are under construction, for how long and why they are still incomplete? How many existing Court Houses and Residential Quarters are in dilapidated condition and what are the plans to repair the same?

All the afore-stated details need to be specified in the affidavit not only of the State of Karnataka but also of the State of Andhra Pradesh.

The matter shall stand over for two weeks.
