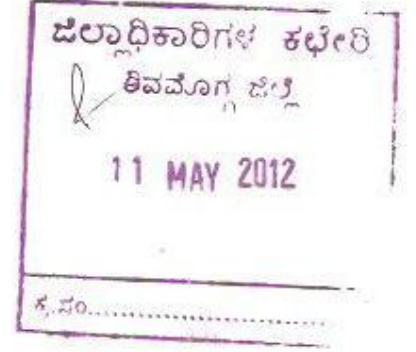

Memorandum: Use and Misuse of Indian Laws and the impact on the society

Respected Hon'ble President of India,

To begin with, introduce myself to you, I am a citizen of the universe, born and brought up in India and residing at Bhadravathi, Shimoga District in the state of Karnataka. For the sake of identification purpose in this huge populated country, I am named as 'Om Vijay Vamshi', living in India and love this country. I wish you all a very happy enjoyable time and bright future to you and to the great cultured colourful country India.

I am submitting this memorandum for seeking your attention to some of the Indian laws relating to protection of women from domestic violence, Marriage, Maintenance and Divorce; and seek answer to some of the questions raised in my mind. Please read this memorandum and think in silence and provide your thoughts on the said laws.

1. I would like to bring to your kind notice, which I feel, needs immediate attention to be taken at the very moment to safeguard the lives of miserable ones, who are suffering just because of the laws of the land. The laws are making the citizens life more miserable than what it is expected to be useful to the citizens of India. Some provisions of the laws are making peoples life more miserable than to safeguard the interest of the aggrieved citizens of India for what it is actually meant for.
2. Without spending much time on talking about issues and problems in India, Straight way coming to the point I would like to mention that the laws relating to protection of women from domestic violence / Marriage / Divorce / Maintenance, these laws which are available in this country to safeguard the interest of aggrieved women and to keep the social life happy and enjoyable. But, these laws are being misused for many reasons for different purposes for the sake of obtaining undue advantage and with bad intentions to threat husband, husband's parents, brother, sisters and nearest relatives.
3. Now you may be bit puzzled to receive this memorandum from me and may be thinking; who is this citizen? Why is he talking about all these matters to me?
4. For your information, I am also the one in among many husbands who has suffered a lot just because of wife filing of a false complaint against me and my parents under section 498A & 506 of IPC.
5. Being a citizen, I thought of providing my opinions and suggestions and asking some questions which I wanted to know the answer from you / the government though this memorandum.
6. I am enclosing the experiences which myself and my family experienced in the name of suffering which is briefly described and named as Annexure – A “My family experience with truth”. You may please go through the same which is attached for your kind study and understanding.
7. I was really shocked and stunned to know that the laws are made in such a way that the misuse of the same causing more damage to human beings. Many persons who have not done any harm, harassment or damage to anyone in this world, who are really innocent and are suffering just because of their innocence and misuse of certain laws.
8. Just for being a husband or being a brother or sister or parents of a (son) married guy they have to suffer a lot, and the laws of the land are always used on the other hand by the criminal minded peoples which are made to use but are mostly used for misuse.

Hence, I feel this relevant laws relating to protection of women from domestic violence/ Marriage / Divorce / Maintenance needs to be reviewed and the public opinion at large to be collected and suggestions provided in this letter needs to be considered in good faith at the earliest in the interest of public and humanity.

9. As we all are aware there are many associations are formed to save the husbands who are living in this country and facing the false prosecution, who has not done any damage or harassed the wife or anyone but still booked a case against husband and his family members under I.P.C 498A and claiming huge sum as maintenance by the wife under the existing laws.
10. The laws are made in such a way that the individual has become helpless in front of the law and the laws are used for undue advantage just for threatening to husband and his family members by many women in this country.
11. To tell you the fact, as and when an ill minded wife files a false dowry harassment case against the husband and his family members; first thing is that husband and his family members has to disappear from their residence or escape from the town and seek for an Anticipatory Bail from the court; even though they know that the case filed by the wife is false, they will not be able to go and present themselves before the police station / court, to tell the truth and to face the situation; even if they go also they will be put behind the bars in the name of investigation and harassed in many ways till they get bail from the court.
12. What I personally feel, and want I want to say is that the individual needs to be little more stronger and ready to face the situations; whatever may be the consequences individual must be ready to face the life the way it comes; groups will be formed by those who do not have any courage to face problems of the self and the society. People are being helpless, taking shelter under the formation of Associations, who are not ready to face their own problems individually with courage; even though they are really suffering they are not ready to take any risk and fight back for their right of peaceful life.
13. I personally feel that, in life we need to take little more risk and be rebel and fight back when we are hurt and whenever our freedom of life is infringed by anyone in this universe, in any manner by filing a false complaint against us or any infringement or threat to a happy and peaceful life.
14. So, as a first step, I am presenting the facts before you for necessary changes required to be made in the law and behaviour of the public servants, politicians, who are elected and employed to serve the society with humanity.
15. In my opinion, the laws, rules and regulations are to be made in such a way that the criminals to be punished for their offence not the innocent. But the laws, rules and

regulations are being made in such a way that the life of the human being is suffering for one or the other reasons just because of the laws of the land which is not allowing the man to live the life with joy and happiness.

16. Just to take an example of the family disputes between husband and wife, how the same has been dealt legally in India and impact of the same on the society; husband and wife not in a cordial relationship to live in the matrimonial house, separates from each other; normally, a false and fictitious case would be filed by the wife against husband under IPC Section 498A & 506 and a case for maintenance. Legal battle would be running years together in court. Husband would be paying the maintenance to wife.

16.1. Now the separated husband and wife are living separate but as we all aware, naturally when we feel hungry we eat food, we feel thirsty we drink water, thus when we feel like need a partner for lovemaking to fulfil the physical needs and desires as a natural phenomenon male needs female partner for love making and vise-versa. But the husband and wife are living separate, now what is the option available to the separated male and female to fulfil their physical needs and desires?

16.2. Is the law is clear or made any provisions for the separated wife and husband to meet and fulfil their physical needs in any manner?

16.3. Ok, the law says that, it is the duty of the husband to take of his wife and her needs, is it not the duty of the wife to take of her husband and his needs and his aged parents?

16.4. For example, to explain practically in detail, when a person gets government employment, in any department, he has to follow certain disciplines rules and regulations, He would be considered as probationary for certain time period and he has to work under the specified rules and follow certain disciplines in his employment, say attendance, fixed duty hours, manners, dress code, how to behave in office and respect his managers, seniors and so on., he would get his salary if he comes to office and performs his duties in the manner specified and works within the office disciplines.

When an employee breaks the rules and does not perform his duties as per the terms and he is not following the office discipline not performing his duties properly, what the government department will do?

The government Department will take disciplinary action against him, his salary would not be paid, if he does not attend to office and perform his duties properly.

When he fails to perform his duties and does not follow the office disciplines and does not attend to office months together, then what will happen? Do the government will pay his salary till his retirement age, just because he has got the government appointment? Do the government will pay pension to him after the age of retirement? No, Know?

- 16.5. Likewise, is there any discipline, duties are fixed for husband and wife in this society?

What to do and how to live, how to take care of each other, how to behave with each other, and how to live together in a married house?

What wife is to do and what husband is to do?

- 16.6. Then, is there any discipline on the wife part how to lead life with husband in the matrimonial house? Does she have any obligation to fulfil towards husband and his aged parents and other family members as a wife?

- 16.7. The law provides that, if the wife is not willing for lovemaking with husband, husband should not force her for lovemaking, if he forces her that would amount to 'rape'

- 16.8. Even for lovemaking, which is the basic reason for marriage, and a natural need of all human beings in husband and wife relation, the husband has to seek his wife opinion and acceptance, if she is not interested what the husband should do?

Is there any alternative arrangement or options are being provided in the laws to fulfil the husband needs?

Can a separated male or female can post an advertisement in newspaper, or display an offer in public places by way of hoarding, pamphlets or brochure or drop an offer and approach in public for seeking a partner for lovemaking?

What is allowable and what is not allowable?

- 16.9. Ok, as the law says the acceptance of the wife is required even for lovemaking, if she is not ready or willing to co-operate with the husband for love making, then what he has to do?

Since, it is natural human tendency to need a partner for love making. If the wife is not allowed his husband for love making where he has to go? Is the Society, Religion, the Government or the law has made any provision or alternative arrangement for this?

Really, I am not able to understand, why for each and everything a laws, rules and regulations have been created? Why human beings are forced to live in the stress and a suppressed manner in this world in one or the other way?

When two human beings, a male and a female interested in lovemaking with mutual consent or like to spend time and live together without disturbing anyone, then why this religion, system, society, government are not allowing them to live the life they wanted to live? Why the same is restricted in the name of religion, custom and culture, even though it is not creating any problems, the same would be termed as adultery in the eyes of law. What nonsense is happening here?

Women who wants to steps out from her house and like to offers herself for lovemaking, the same is not allowed in this country, then what freedom has been provided to the women in this world? The law prohibits the same and is treated as an offence in the eyes of law. What is wrong in that? I do not think so, that it is anybody's duty or any country law's business to interfere with two person relationships or the way of the life, they live with mutual consent.

- 16.10. Now, to take my own example as detailed in Annexure – A; wife wanted to marry another guy and got married to me as per her parents wish, for some reason, now she is not interested to lead life with me; files a false and fictitious complaint against me and my parents and seeking huge money as maintenance. Now the law of the land says that being a husband it is my duty to provide the maintenance to wife, so I have to pay money to her for her life maintenance.
- 16.11. That's ok, now who will take care of my needs?

If I am not well or got some health problem, who will take care of me and my aged parents?

Does the wife, do not have any duty to fulfil?

What do I need to do for my natural physical needs for lovemaking?

In case, if I find a women who is ready to offer herself for lovemaking and interested to spent time with me, the same be termed as illegal relationship, illicit relationship and would be treated as an offence in the eyes of law. Then what is the remedy available?

I seek your prompt and honest reply for all the above mentioned questions.

17. Mis-use of laws:

A wife files a false complaint against husband, his parents and his family members under Section 498A for many reasons; once a complaint is filed by the wife, police will put husband and his family in jail, till they get bail from court in the name of investigation.

Further, wife files a case against husband for maintenance and share in the property; most of the cases, court grants maintenance to wife based on her husband earnings. Further, at the end the family dispute will end in divorce, wife receives a huge sum of money as compensation for granting acceptance for separation and divorce.

Innocent and lovely children's suffer a lot due to the husband and wife family disputes and separation.

18. Now coming to the point, few women's are using the available laws for the sake of their benefit and the laws are being misused for undue advantage and to take personal revenge for many reasons, thus this laws are creating more harm to the society and playing with many lives and is threat to humanity.

19. In India, a complaint is given by a wife saying that she was harassed by her husband and his parents and relatives for dowry or for money or for any other benefit; a case will be filed against the husband and his family members under Section 498A along with 506 and put them behind the bars; since, case filed under Section 498A is non-bailable and that to it will take some time to obtain bail from the court, till time, the husband and his family members has to spend time in jail.

Coming to the point, I would like to say that even in case, the allegation made by a wife against her husband and his parents, sisters, brothers is false or right, the police will harass the husband and his family members and put them in jail; the pain and sufferings, the mental situation they pass through, during these days cannot be expressed in any words; it would be better understood only by the people who are got into the trap and suffered a lot.

20. One more point to mention that Many Women Associations, Mahila Shangha, are supporting to the women who is ill minded and these Women Associations are doing protest before the husband house creating nuisance in the area and thus making the family reputation down and just want to show up their beautiful faces on media pretending as doing great job in this society. This Women Associations who are supporting the ill minded wife for obtaining undue advantage of being a woman in this world needs to be stopped.

21. Husband and his relatives are tortured in many ways by ill minded wife the police and Women associations.

22. As we all know the dispute between husband and wife would arise for many reasons even for silly matters which may seem to be very funny to anybody but would take serious contradictions and disputes between husband and wife.

23. We may note that even in this 21st Century, till today many marriages are being fixed by the parents of the girl or boy without considering the boy or girl opinion or will for the marriage.

The girl or boy may be interested or like to marry their choice of boy or girl. The parents are aware of the fact that their girl or boy likes or loves some one of his/her choice, but, the parents will not allow the boy or the girl to get marry to their choice but would oppose and force them to get marry with one whom the parents like or selects for many reasons like caste; religion; status of the family and so on.

Due to these kind of marriages which are fixed without the free consent or will of the boy or girl so many disputes would arise, for many reasons, if anything goes wrong between the husband and wife or for any other reason disputes arises between husband and wife and the wife commits suicide or something goes wrong with the girl that would be highlighted as harassment by the husband and his relatives for dowry and a case would be filed by the wife, against the husband and his parents and other blood relatives.

24. In recent days, any disputes or misunderstanding arises between husband and wife would take shelter under dowry harassment and a case would be filed under Section 498A & 506 of IPC, which is always not right on the one part, but still the wife and her family members are managed to file a false dowry harassment case to hide or to safeguard their family internal weakness.

25. Filing of false dowry harassment case is an evil to the society and threat to many families, many are suffering because of filing of false dowry harassment case by the wife; the husband and his family reputation are being damaged; many husbands and his family members are lost their life.

26. I have made a survey on the filing of cases under I.P.C Section 498A, family disputes between husband and wife, divorces in India and the problems of single parenting, children suffering due to family disputes and impact of the same on the society and how the humanity is suffering in family disputes.

26.1. In India most of the cases filed under section 498A are false, in many cases the husband and his family members who is not able to sustain the stress and to face the society by losing their reputation, not able to face the friends and relatives has ended their life, by committing suicide.

Many association are been formed by the people who are suffered a lot like me and shared their grievances and fighting in group, doing protest, creating awareness in the society and they are really helpless and not able to do anything, some have lost their jobs, reputation, facing the prosecution and paying maintenance to wife and paying huge amount for settlement of cases and to get away with the harassments to lead a peaceful life.

26.2. To tell you my own family case, whenever there is any different of opinion between me and my wife, my wife wanted always her opinion to be considered and lead the life the way she wanted, she is always fond of her parent house, I was supposed to drop her, to her parent house in car whenever she wanted to go, even though I am getting late to my work, some time, due to time constraint I was not able to drop her, she use to create nuisance at home and use to threaten me to call police and tell them that I am harassing her for dowry.

She use to threaten me saying that she would file false dowry harassment case against me and scream and create nuisance in the house, and threatens that she would report to T.V, media against me and my parents, I was really suffered a lot keeping all these things within me, and I was just leading life with lots of compromises listening to all whatever she wanted and likes just to avoid the other third person to know about our family and to safeguard my social image and thinking that my parents would suffer, if I share or tell these facts to them. My weakness was my family, my social image and was afraid of discussing the same with my family and friends and in public. That was my weakness and she was taking advantage of my weakness and use to threaten me in many ways. But as we all know and say everything has an end, the difference of opinion dispute gone out of the house and become public.

At that moment even, I do thought of committing suicide thinking of losing my social image and family reputation and my job. Finally, took some time to came out of it and discussed the matter with the friends and family members and discussed the matter in public, then I came to know that this is happening not only in my family many families are suffering like me.

Then, I decided to face the real world and fight back for my right for peaceful and joyous life. I am prepared myself to lead the life the way it comes, then

consoled myself saying that, why should I commit suicide like a coward or run away from the crowd or compromise for settlement by paying a huge sum of money, just for the sake of my identity, job and public image.

Let me face the world, society, system and the law and fight for my right, even if I have stay in jail for fighting for my right to live peaceful and joyful life, let it happen. I don't bother, I will fight for my right and for the sake of humanity without any hesitation or expectation and I will express all my opinions.

Anyway, we all know, we are all going to die one fine day, then why to die in shy, and pose like a good civilized man by binding our self; wearing beautiful masks; keeping many thing inside, dividing the existence and differentiating between good and bad; right and wrong and live in repression, suppression; losing the joy and beauty of natural life gifted by the very nature; just for the sake of protection of social image and reputation.

Please note that nothings is wrong in this world, whatever is existing and available on this earth is right; remember, life needs to be lived, not to be repressed; everything available and gifted by the nature has to be used and enjoyed in such a way that the life becomes an holy pilgrimage towards the reach of humanity; nothing is wrong and nothing is bad; I am sure that the mother nature will never create anything bad or create anything wrong which is harmful to humanity; only thing is that the things should be used in a right way for the sake of humanity.

To tell you honestly, I will follow my heart and will live the life naturally without repressing anything; whatever may be the consequences, I am ready to face and live naturally; ready to accept challenge, whatever happens to me and my family, let it happen. I will not compromise and repress anything in my life for any reason.

Myself and my family has suffered a lot for being a good human beings, who has not done any offence but, still got charged a criminal case under Section 498A & 506 against us and wife filed a separate case for claiming maintenance and compensation.

- 26.3. To tell you the other families who suffered a lot due to the family disputes I would like to mention the few incidents and true facts for your study and review:

A guy who was employed in government department got married; there were disputes in family life; wife committed suicide; wife parents and brothers filed a case against the husband and her parents and his brother saying that the

husband and his family members are responsible for her death, in fact, the husband and wife were living separate and away from husband's parents' house, still a case has been booked and the husband was arrested and put in to jail for years together, his family suffered a lot. Finally after all happenings the case against husband family proved to be false; now he has been released from Jail and his parents and brother, suffered a lot in between.

To say another incident, Due to dispute between husband and wife for long years, got fed up for many years tolerating the torture and threat of wife, not able to share his feelings with friends, family members and relatives; living in stress and not able to handle the situation, finally committed suicide.

- 26.4. You can Google with words “498A”, “false dowry harassment case” you would be able to know the depth of the misuse of 498A and the pain of the families who are suffering and charged under IPC Section 498A.
27. To overcome with the problems of the mankind and for the safeguard of the society and to keep the country domestic family life happy and healthy, I suggest certain recommendations; these recommendations are suggested with a good intention to avoid the misuse of the laws and for the sake of humanity and for the benefit of the public at large.
28. I believe that, life is to live and leave. A person born in this world sure will die one fine day, life lies in between birth and death, so let's celebrate and enjoy the life with love and lets spread love and joy around the world and eliminate the sorrow, hate, and worries from this world. So, let us all, live in love and lead a peaceful, happy and enjoyable life.
29. Myself, and my family suffered a lot just because my wife filed a false and fictitious case against us. She was not interested to lead life with me; she was interested to lead an independent life, the way she likes. But she finally ended up the relationship by filing a false, fictitious case against me and my parents under Section 498A & 506 of IPC and a huge maintenance claim case filed against me. Whatever has happened with us has happened, and we suffered a lot.
- But really, I feel pity on my wife and her family members, because they are doing all these just for sake of this society and wanted to project themselves as good people by wearing a beautiful mask by keeping their ugliness inside, telling lies and not able to lead and face the life reality and used the available laws for their advantage to extract money.
- I do not want any other family to suffer as we suffered, so I am making this representation and suggestions for the sake of humanity.

30. Going through the present laws of the land, I would like to mention certain recommendations, further I suggest that an open public discussion and debates to be made on the matter and public opinion to be collected and suitable amendments to be made in the laws for the betterment of huge public for the sake of humanity. The recommendations mentioned hereunder are to avoid or to minimise the filing of false cases by wife and her family members against husband and his parents and relatives.
31. The recommendations and suggestions provided herein below are for your review, discussion and consideration.

- I) We may note that in many cases, where husband and wife are living separate from husband's parents in different places. Still, the parents of the husbands are being targeted and included in the dowry, harassment case and a case will be filed against husband and his parents and other relatives. So it is suggested that; under Section 498A a case may be registered only against the husband not against his parents and his other family members.
- II) The Family disputes and allegations between husband and wife filed under Section 498A / 506 would be treated as bailable offence.
Why I say so, is because whenever a ill minded wife files a false and fictitious complaint against husband and his parents; they will be arrested first in the name of investigation and put them in jail till they get bail; to avoid that, I suggest all family disputes between husband and wife be treated as a bailable offence
- III) To minimise the false 498A cases; wherever it is found that the wife has filed false complaint against husband for undue advantage or wife misuses the laws; punishment or penalty to be imposed on wife.
- IV) To curtail or to reduce false cases filed by the wife / high income source husband's wife for claiming undue advantage of being high income earning person's wife who claims huge maintenance or partition in assets or high compensation. It is suggested that, whenever a wife files a case under section 498A she would not be allowed to file any other case against husband or his relatives; or for claim of maintenance or property.
For wife, minimum basic life requirement to be provided for her maintenance of life; maintenance award should not be provided to wife based on her husband's earnings; so that this would enable the wife to get her needs for necessary not the luxury of life.

In many families we may note that, some guys' likes to marry a girl from a poor financial background family; believing that, they would lead a good life and these poor family and non-working girls will adjust lead a good family life. Many times, there is chance of these people taking advantage of being a wife of a rich husband they would take advantage of that, and would explore the opportunity of getting huge settlement of cash as maintenance, so it is advisable to keep the maintenance to necessities of life.

- V) Further it is suggested, as another option, that government should issue an Identity card/Ration card to the wife; wherever she is in need for maintenance of self and kids at the time of filing a case against the husband for maintenance, so that she can take necessary food stuffs from Government food supplies depot, for her maintenance from that card; with medical facility at government hospital. And in case wife requests and requires for accommodation to stay; wife to be sent to government caring houses as long as she needs it or till she finds an alternative. The cost incurred towards all these expenditures may be claimed by the Government from the husband as arrears of taxes or land revenue.

This kind of identity card / ration cards and facility would curtail maintenance cases against husband and also helps to ensure that the wife is getting her maintenance in time. And this would be a lesson to those, who thinks of that even without her husband, can lead a luxurious life, by claiming huge maintenance from her husband based on his earning with an ill intention to lead an independent free life away from husband.

- VI) Maintenance to be provided only when she is not in a position to earn; if she is /was working / is having opportunity to work she would be eliminated from maintenance; until unless she is not in a position to earn for her livelihood; minimum, basic necessities to be provided.
- VII) Husband and wife must live together for a minimum period of 10 years (Ten years) to claim right of share in property or assets of the husband. Otherwise, No share in asset to be given to wife.
- VIII) Once the wife files a case under Section 498A or an application for claiming maintenance the application may be deemed to be considered as application for divorce and the husband and wife be treated as divorcees and living separate.
- IX) It is suggested that, to file a case against husband, a material and clear evidence to be provided by wife to the police officer or to court. Just an oral evidence of wife / her parents should not be considered as strong evidence to take legal action against husband or for filing a dowry harassment case against husband.

Why I am mentioning, is that now a days the wife whenever she files a case under Section 498A just goes to hospital saying that the husband has beaten and she got hurt from her husband and his parents and obtains a certificate from the doctor; this seems to be very common, why I say is because, my wife did the same thing; I am still not able to understand; how the doctor has given certificate to my wife?

X) At the time of marriage itself, a committee may be formed to resolve the disputes between husband and wife. In case of any dispute, husband or wife would go before the committee; the committee members are to be witnessed for any matter of dispute at the time of filing a complaint against husband or wife or at the police station or court level in case of family dispute.

XI) It is suggested to legalise the lovemaking services in India, so that the interested male or female, attaining the age of majority can provide or avail these lovemaking services to fulfil their physical needs and desires with mutual consent.

Also suggested that, Proprietorship, Partnership, Private, Public limited and Multinational Company (M.N.C) may be allowed to establish and provide love making services in India; so that this would enable the interested persons to avail the services who are single, divorcee, or living separate from husband or wife and who is not interested in marriage, they can avail the lovemaking services.

This kind of love making service centres will help the needy persons to fulfil their physical needs and desires. This will be helpful to minimise the criminal offences like rape, child sexual harassment and other sexual crimes in the country. This will also help to eliminate homosexuality from the country and allow men and women to love and live the life in a more natural way.

XII) I understand and believe that, caste, religion, culture, community, reservation for men and women all these divisions are used for centuries, just for the sake of politics to get into power, to rule, and ruin the humanity in many ways.

Why the government and religious leaders are dividing the humanity in the name of caste, religion, culture, community, man and woman?

Why the government is not removing these divisions from this country?

Why different laws are being created in this country for human beings, based on religion, culture and community and so on?

It is suggested to remove caste, religion, community, reservation from the country and make a single unique law which is applicable to all human beings in this country/universally; irrespective of sex, caste, religion, culture or community. It is advised to remove from the bias in the name of religion, sex, caste, community

and make the human life simple to lead a happy and peaceful life with good intention.

Let the people follow and belong to any religion, caste, community anything they like but the government should eliminate all this from its agenda while making laws, this would lead the country to move towards equality in the path of humanity.

XIII) It is suggested the government to treat men and women as natural human beings. Why the government is not treating women as a natural human being like men?

Why the politician, governments, society, and many religious people are trying to show to this world that women is not capable of leading a life like men and trying to bring equality between men and women in this world?

This seems to be absurd and stupidity, whosoever talks about equality of man and women.

Men and women are two opposite sex beings; they are fine and happy as they are, as long as they live naturally. So it is suggested to remove the bias between men and women while making laws.

XIV) I believe that, neither women can be made equal to men by providing a legal right or political position or by creating some special laws; nor men can be made equal to women by making some laws or by eliminating men from being in political power.

Please try to understand, men and women both are two different faces of a single coin of humanity. Neither the men is great not the women, both are natural human being, both are fine and good as long as they live their part of life naturally.

I request, the Government, political parties, politicians, religious leaders and all living men and women of this universe; please do not try to differentiate between men and women; inferior and superior; and stop try to bring equality between men and women just for the sake of ruling or for power politics. Men and women are really 100% fine in living their life in a natural way, as they are born and living in the world.

32. Further, I like to mention that, in this present world, people are living and running behind money, power and property; people are more worrying about the materials and become more materialistic. People are living just for the sake of living by leaving the essence and joys of life and are running behind acquiring more power, property and many things and forgotten the basic values of humanity and mankind. People are living more for society, caste, religion, community and suppressing many things within self,

down the heart and pretending to be good by wearing beautiful masks to cover the dirty, ugly, devil face and forgotten to live the life like a natural human being.

I feel that, people are much bothered for their identity and ready to wear beautiful mask and not ready to speak openly their opinions and express their feelings openly; just busy in protecting their social image; and thus are living in suppression and are missing the real essence life and living in stress.

I do was lived in suppression till day, but decided to express and live the life naturally and to express all whatever I felt without any limitation or hesitation. To tell you, I am what I am, so I am just expressing my opinion openly whatever I feel right and is necessary for the sake of humanity. I will just do it and go for it.

Anyway, one or the other day we have to leave this world so why worry, whether today, tomorrow or this very moment. I am ready to go for it and I am ready to fight for my right to live in this universe the way I like and feel, by expressing my opinion and I am ready and happy to take responsibility, challenge whatever comes on the way of my life.

33. I believe that, life should be like a flowing river, so I express and tell all whatever I feel. I do not differentiate between good and bad things, the good and bad will always changing from good to bad and vice-versa based on the life experiences and opinions from persons to persons. So, whatever is there in this universe is there, nothing is good, nothing is bad.

If any government, religious leaders, political parties, or any community is there on the other side to challenge my view; I am ready for the challenge. To discuss and exchange the opinions and I am ready to receive and accept opinions and challenges.

34. All these years, I lived in the world for the sake of job, earning of livelihood and living for my family for the sake of others and for the society at large by following the rules and regulations; but finally what I got for being a follower of the crowd and society and for sustaining all the harassments. I and my family got trapped in a false allegation and become an accused in criminal case; and held liable to pay compensation and maintenance to wife, who filed false case against me. Then I got realised that after losing my all these years reputation and social image, it is better to live like a natural human being without suppressing anything.
35. If any laws, rules and regulations are made in such a way that it is threat or hurdle to live and lead a life in a natural way, then the law, rules and regulations needs to be changed but not the individual to change for the sake of law; hence it is advisable to change the law and make the law in such a way that life to be more joyful.
36. Being a natural human being, I decided to do all whatever a natural human being will do to lead a happy, peaceful and enjoyable life. In my opinion, if anything is restricted by

any law which is a hindrance to happiness and is threat to mankind; then the laws, rules and regulations needs to be discarded or amended.

37. I am a free man, born in this world and I will live my life the way I like, I am not belonged to any particular country, caste or religion or government, created and followed by the human beings, any living human being who want me to follow any rules, regulations and law may come and contact me personally.

Further I declare and intimate to the government that from today onwards no laws are applicable to me, which are made without obtaining my personal consent and acceptance. Many existing laws are made well before my birth and without my knowledge, this government, religious leaders are trying to impose on me many laws, rules and regulations which I am really not aware of it, hence, I am not ready to follow and accept any custom, laws, rules and regulation which are made by the government, which I am really not aware of it and are done without obtaining my free consent or opinion.

I will accept and follow only those laws, rules and regulation which are accepted by me personally. So it is advised that, if any government or society or country or any religion, or any community want me to follow any laws, rules and regulations they may communicate me in writing before making any laws, rules and regulations and seek my personal consent for the same.

38. I was living like a layman in this country by following the laws, rules and regulations which I know normally, but I got arrested in a false case filed by my wife and a criminal case is filed against me and my parents under IPC Section 498A.

I was not aware of the laws, rules and regulations relating to IPC Section 498A / Marriage / Maintenance. So, I got caught even for not committing any crime or offence, myself and my parents suffered a lot and I have lost faith in the government, laws, rules and regulations, religion, caste, community, society and system.

I, understand and believe that, the laws relating to Marriage / Divorce / Maintenance are made is such a way that it is biased and are not clear. I was not aware of these of laws, rules and regulations. At the time of making these laws, If, I would have been aware of that, this kind of law is going to be implemented in India and are going to applicable to me, I would have been opposed and would not have been provided my consent for implementation of these laws. Thus, there may be many others laws, rules and regulation in this country, which I may not be aware of it now, and in future I may have to suffer for one or the other reason just because of the laws, rules and regulations which are harmful and biased and threat to mankind and to me. So, I do not accept the notion and saying that 'ignorance of law is not an excuse'.

To, tell you honestly, I am really surprised, and not able to understand how the government, society and this system is running all these years making fun on people and burdening the citizen life, by creating tons and tons of laws. I am not sure about the total number of existing laws in force as on date in India; but my wild guess is that, at present in India there may be more than 10000 (Ten thousand) laws, rules and regulations and amendments on amendments to the laws are existing. To speak out practically, how the government, the system and the society expects that a citizen should be aware and follow tons and tons of laws and expect to keep update and be aware of the existing laws and amendments up to date? Is it possible for anybody to study, read and keep in memory and follow these tons and tons of laws, rules and regulation? So many illiterates, people don't have proper education to read, understand and interpret the laws, in these conditions the saying "ignorance of law is not an excuse", seems to be so funny and kidding with the people of the country. For a literate, human being to read, understand and analyse all the existing laws it will take years together time and the update and amendment will be happening every day by way of court judgements, amendments, precedents and difference of judgements on interpretation on interpretation and so on. How much time an illiterate will take? If that is what is expected from a layman in this country, then, where will he get time to live and lead life in this country?

hmm, how can you expect me to be aware of all the existing laws and related rules and regulations made in this country? There may be many laws which are threat to mankind and biased, may be other citizens or human being can accept your law; but I am not going to accept it, until unless you convince me the need for the specific laws, rules and regulations; existing, laws rules and regulations are not applicable to me. I further, declare that from 09 May 2012 onwards, I will not follow and accept any laws of this country which are harmful to me and to my family to lead a happy and peaceful life in this universe.

So, never be the late, I am giving notice to the Hon'ble President of India, the Government, public and all living beings on this earth, declaring that, I am out of all the laws, rules and regulations made by the Government. Further, declares that, I am not aware of any laws, rules and regulations and I live according to the way I like. In case, the Indian government or religious leaders or anyone one who like to bind me to follow any laws, rules and regulations, they should come and contact me in person.

Further, I am giving the notice through this memorandum to you, the Hon'ble President of India and request you to appear in person on 30 May 2012 at 11:00 A.M on the

address mentioned above, before me with list of all the existing laws, rules and regulations and convince me the need and the necessity of so many unnecessary laws, rules and regulations and explain me; why, I should follow the government laws, rules and regulations of this country / universe? What laws, rules and regulations are applicable to me? And obtain my acceptance for the same. Failure to present before me in person on 30 May 2012 at 11:00 A.M on the above mentioned address would be deemed to be treated as no laws, rules and regulations are applicable to me and to my family/parents; for any reasons, in any part of this Country or universe.

39. Further, I mention that, I being a natural human being, I do need to fulfil certain basic needs to live like a natural human being on this earth as every human being needs for living in this world. As we are all aware that, as a natural human being, we do need food when we feel hungry; water, when we feel thirsty; and a male/female partner for lovemaking to fulfil the physical needs and desires.

Hence, I would like to inform you and to the all the governments in this world that, any act done by me in good faith and for want of basic needs would not be treated as or termed as illegal; and the same may be treated as necessities of life and be considered as a legal activity.

40. Further, I mention that, I will not be held liable for any act or anything done by me in good faith for the basic needs and for necessities of life; whenever my freedom of life is infringed by anyone in this world in any manner and whoso ever it may be, I will fight for my right to lead a happy and enjoyable peaceful life in this universe.
41. I hope and believe that this memorandum would be considered in good faith for the sake of humanity. Whatever the suggestions, recommendations are provided and answers sought for questions in this memorandum are my personal questions and suggestions.
42. This memorandum is submitted for the sake of public at large and for betterment of humanity and not for any personal benefit.
43. To obtain public opinion on this memorandum, the government may discuss this memorandum in public, media, and in parliament house and also obtain opinion of members of parliament and public at large.
44. I request the concerned government authority to provide answers to the questions raised and discussed in this memorandum within 30 days (Thirty days) from the date of receipt of this memorandum.
45. This memorandum is submitted for discussion in the Indian Parliament House and all the State Legislative Assemblies in India. I would like to be a part of the discussion on the matter. Hence, please intimate me 30 days (Thirty days) in advance to the above

mentioned address, before the date and time to be fixed for discussion of this memorandum in the State Elected Legislative Assemblies and Parliament House

46. I look forward for a mankind response to this memorandum from the Hon'ble President of India.
47. I personally thank all the public servants for their service, support and hard work, who are working round the clock for the betterment of the citizens.
48. Finally, I request you, all the citizens of this country, Political leaders, Political parties, Members of Parliament (M.P), Members of Legislative Assemblies (M.L.A), Members of Legislative Councils (M.L.C), all the Government employees, Government officials, Corporate entities, Educational institutions, Companies, Business leaders, Judges and Advocates, Media and Press, Religious leaders, Women Associations, Students, Senior citizens, Youth and all living beings, to discuss this memorandum in detail and speak out and provide your suggestions, opinions openly.

Further, I like to say that, I am also one among you, you may also feel the way I feel, I am expressing here, on the other hand you may repress it for the sake of protecting your social status and reputation; which is life negative, so request you to, please be positive and brave enough to face the realities of life and express your opinions honestly and openly.

Please try to understand life is really beautiful, and always remember, we all human beings here for some time on this earth and will disappear from this earth by leaving all our religion, caste, community and political party, power and everything we loved, lived, owned and earned. So, let us all forget our Caste, Religion, Culture, Political Party and Community created by centuries ago for many reasons, to divide and to rule the humanity for the sake of power politics.

I believe that, even in this 21st Century, people are still not ready to speak out the truth and accept the facts and realities of the life. People are not ready to discuss and talk about the division of human beings, category, caste, religion, quota, community, minorities, reservation, and sex and so on. Believe it this is one of the golden opportunity to discuss anything and everything openly without any hesitation and an open option to accept and choose your life, the way you like in full 100% natural way without dividing the things and behaviours between good or bad; right or wrong; just to live and accept the realities of life and the fact as it is naturally. This is an open option and right time to bring changes in this country.

You are born free, you can follow any religion, caste, culture and custom and so on whatever you like; and you can lead the life the way you like; but, speak out and provide your honest opinion and acceptance to remove all the rotten reservations, division of

human beings, caste, religion, culture and quota, from this country's political agenda and legal system. Let us all try to make, one common law, which is applicable to all human beings in this country for the sake of humanity. Believe it, that your opinion also matters a lot. Ok, Just do it! Right Now.

49. Let us all join hands together to build a happy, healthy and wealthy universe and good human relations on this earth.
50. Let us all promise ourselves and take an oath in the name of humanity; saying that, "We will not divide the humanity in the name of caste, religion, community, custom, culture and political party, and fight for the same; we will live in this world whatever the way we like without bothering other living beings on this earth; we will express all without repressing, suppressing anything and will live naturally; we will live as a lively human beings, as we are born like a child by leaving all our egos behind; we will not wear any masks and will the life natural the way it is, till the last breath of our life; we will hold, hand in hand and will spread love and happiness around the world by singing, dancing, celebrating the life with joy and will enjoy the life, the way it comes.

Annexure – A

My family experience with truth

A true fact and suffering experienced by myself and my family members are provided below for your kind study and understanding

Brief background of my family for your information and imagination:

- My father, aged about 76 years retired as an employee of Vishweswaraya Iron & Steel Limited (VISL);
- My Mother, house wife aged about 68 years;
- My parents having total 5 children; 3 sons and 2 daughters;
 - Two daughters got married and living with their husband house;
 - 1. Elder son got married, living separate from parents;
 - 2. Second son got married, living separate from parents; and
 - 3. I am the third son who was working and living in Bangalore separate from parents
- Since, children's got married and living separate and away from parents, aged parents has no option left, has to live their life together in Bhadravathi and living in Bhadravathi.

Brief facts:

1. I was working in private in Bangalore; Marriage was an arrange marriage; I was got married in the year 2008 to a Bangalore girl; in the marriage we have not asked or received anything in the form of gift or dowry.
2. My house was near to wife's parent's house so once I go to office, most the time she use to go to her parent's house and spend time there, saying that I am alone and bored to stay alone, before marriage the girl was working and after fixing the marriage with me, I was not interested to send my wife to job, so she left the job and was at home; In the beginning I was not objecting for that since, we are newly married, I was just not opposed for her wish to spend more time with her parents. While going to office I use to drop her to her parent's house and while coming back I use to pick her. Likewise, the life was going on; After some days I started to oppose her to visit her parent's house regularly and stopped dropping her to her parent's house thus the dispute arose between the husband and wife; and while in the argument time, she expressed that she would have been got a better husband than me and she said she was interested to marry her office colleague but her parents were opposed for the same and fixed

marriage with me. After knowing that I said, you just forget the past whatever has happened or whomever you wanted to marry, just forget the past and lead life with me, if you don't want to lead life with me you can take your decision; and after that she started to show her anger on me for simple silly matters; when this was not tolerable I spoke to her parents and intimated them about her attitude towards me, and questioned them why you people got married her to me when she was interested to marry a guy of her choice? For that her parents said that she is too young, she doesn't know the reality of life; we will tell her to lead a peaceful life with me. Thus the life was going on.

3. Out of the married life, we got a female child and after that I shifted my house to a different location which is bit far from her parent's house, earlier it was very near to her parent house; thus whenever she want to go to her parents' house she use to ask for me to drop her to her parents' house and go to office; the office and her parent house was in two different directions; sometime I use to drop her and sometimes I was not able to drop her; for that she use to fight with me saying that who is important to you? Your wife or your work? you choose one, if you are not going to come with me to my parent house I will go alone and I will not come back; this was happening very often and I use to intimate to her father many times he use to come and convey her to lead a peaceful life. During these days she was not so co-operative and started to threaten me saying that if you complain about me to my parents, I will file a false dowry harassment case against you, I will tell the police and tell media that you are harassing me for dowry. That was not tolerable to me; I was in total confusion, I do not wanted to say this things with my parents who are aged and living away from us will think about us and will spoil their health; so I was just managing and was leading the life as per my wife's wishes, after some time when she started to threaten me to commit suicide and write my name in the suicide note, I was really disturbed a lot, mentally I was not able to sustain these kind of harassments; so finally I wrote a letter and handed over the letter to her father and said she is not interested to lead life with me, she threatens to file false complaint, and some time she use to threaten that she would kill me. When this matter was discussed at her parents' house, I felt alone and finally decided to discuss with my close friends and slowly with my parents; when the matter was discussed by both the family members; my parents put a suggestion to shift the family to my hometown Bhadravathi, but my wife and her parents and relatives were not ready to send my wife to lead life in Bhadravathi and they said 'No' to shift the family to Bhadravathi and promised me saying that we will ensure that, she would lead a peaceful life with me.

Then further we started to live in Bangalore; In between my wife's sister marriage was got fixed and for the marriage my wife asked me to pay money to his father as a loan, for the marriage expenditure and borrowed money from me. I paid the money without intimating to my parents.

4. During the month of March 2010, she picked up a quarrel with me and left my house and finally she started to live with her parent's house. I came back to my home town, Bhadravathi and we were living separate from March 2010.
5. After 6 months, during the month of October 2010, my wife along with her parents and some members of a Women Association / Mahila Sangha came to my hometown Bhadravathi and filed a false dowry harassment complaint against me and my parents in Bhadravathi Police station.
6. During the month of November 2010 we all gathered in the police station; in the police station I have explained all the facts from the beginning to the police officer and said that the wife is making false allegations against me and my parents, and further explained that; the complaint is false; wife's father has taken money from me; during the discussion in the police station in front of the police officer and Women Association members, my wife and her father accepted that they have borrowed money from me. On that day the well-wishers and friends present there advised me to forgive them for the false complaint and to lead family life in Bhadravathi. Thus again we started to lead life in Bhadravathi;
7. During the stay in Bhadravathi, again she started to act same as earlier; she use to say that I want to live in Bangalore; I do not want to live with you in Bhadravathi. Thus she was creating nuisance at home but her family members were very much supporting her. And during the month of February 2011, we intimated the police officer saying that you suggested us to forgive her for her false complaint and to lead life with her in Bhadravathi, but she is threatening us to file a false complaint against us what to do? Further the police officer said to file a complaint against my wife, so we filed a complaint against my wife and her father. After knowing that we have filed a complaint she started to threaten us saying that she will commit suicide and write our entire family members name in the note. We were all afraid of her threatening, after that she left my house and started to live in Bangalore.
8. After sometime, I contacted with the police officer and my friend an advocate, and discussed the matter; they suggested to send a legal notice to wife; so we sent a legal notice to wife; after the receipt of the legal notice, she came to Bhadravathi alone with my daughter; after 2 days her father came to Bhadravathi and threatened me to take back the complaint and lead life in Bangalore with her daughter; I was not ready for

that and denied for their proposal; and the next day in the morning my wife went to police station and filed a false and fictitious complaint and a case was booked under Indian Penal Code Section 498A, 506, 323 against me and my parents in Bhadravathi. Further my wife filed a case in Bangalore under the Protection of Women from Domestic Violence, Act, 2005 seeking maintenance of Rs.60,000 per month (Rupees Sixty Thousand per month) and Rs.25,00,000 (Rupees Twenty Five lakh) compensation and asking for share in property’.

9. After obtaining bail, I met the police officer and asked him, you are aware of the fact that the complaint is false & fictitious, still why did you filed a case against us? For that he said the laws are all in favour of women, I will not be able to help you.
10. During these days we have suffered a lot; due to this false allegations and case filed against me and my parents; my parents are aged and they feel that they have lost their social image and reputation; day by day they are becoming very weak and leading their life with lots of pain by spoiling their life and taking more and more medicine.
11. At present the following cases are filed against me and my parents and the same is pending for hearing and disposal.
 - I. A false criminal case under IPC 498A, 506, 323
 - II. A maintenance case filed in Bangalore for seeking
 - a. Rs.60,000 Per Month (Rupees Sixty Thousand per month) as maintenance
 - b. Rs.25,00,000 (Rupees Twenty Five lakh) as compensation
 - c. Share in the property
 - d. A own / rented house for her stay in Bangalore
12. This is the true fact, even the police officer who filed the case, is aware of the fact that we are innocent, but he is not able to do anything to support us in support of justice.
13. The Women Association / Mahila Sangha members who were present on the day of discussion at the police station with whom my wife filed complaint, is fully aware that we are innocent and we are trapped under a false and fictitious criminal case, still, they are not able to come and tell the truth and support us.
14. The middlemen through whom the marriage is fixed and other relatives who is aware of the fact that the complaint and allegation made by the wife is false, and aware that we are innocent, but still they are not ready to come and tell the truth before the court.

15. What is happening in India? How these police officers are performing their duties in India? I am really not able to understand. But, still we have to live and lead life with in this society, so we are living for hoping for good and in believing that we will get justice.

16. Let us see what happens and where this will end in the fight for justice.
