It is hereby notified for the information of all concerned that the Competent Authority has been pleased to direct as under:

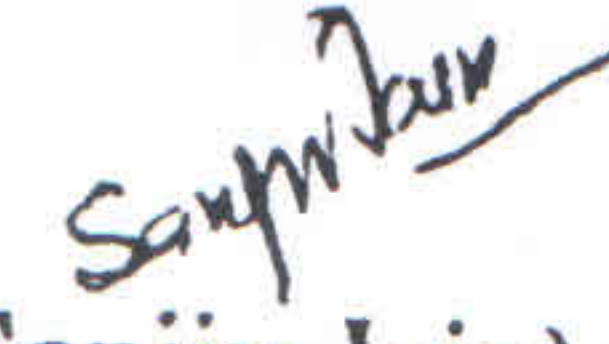
