

Matrimonial re-union by Wife and Husband with Mutual Consent

This **Deed of Matrimonial re-joining** is made and entered on this day of September, 2017 at Hyderabad, TELANGANA, INDIA. By and between:

Aged 30 years, Occupation: Contract Employee (xxxxx, Hyderabad TELANGANA, INDIA).

(Hereinafter called as the “**FIRST PARTY**” on one part)

AND

Mr. Husband H/O Wife

S/o xxxxx

H.No. xxxxx, TELANGANA, INDIA.

Aged 33 Years, Occupation: Private Employee at Hyderabad, TELANGANA, INDIA.

(Hereinafter called as the “**SECOND PARTY**” on other part)

WHEREAS, the First Party and the Second Party are the legally wedded wife and husband and their marriage was performed on xxxxx at xxxxx, TELANGANA, INDIA as per Hindu rites and customs in the presence of elders and well-wishers & relatives and it was an arranged marriage. Whereas, after the marriage First Party joined the company and society of Second Party and lead happy marital life and out of wed-lock, First Party & Second Party were blessed with a baby boy on xxxxxx.

There were some mis-understandings and disputes which arose between the parties. Due to these mis-understandings, on xxxxx First Party devoured pills (thyroid) which caused stomach ache and was admitted in Hospital, xxxxx, Hyderabad. Hospital Management referred this as MLC (Medico Legal Case). This MLC case took over by xxxxx police station, Hyderabad, TELANGANA, INDIA. After their enquiry, police station referred this case to Family Counselling Centre (Bharosa) at xxxx, Hyderabad. Family Counselling Centre conducted 1st & 2nd counselling to both the parties, which were scheduled on xxxx & xxx and both the parties were present. First party did not attend 3rd counselling scheduled on xxxx. Family counselling Centre called First Party for further counselling, but First Party did not attend the counselling as per scheduled. Later family counselling Centre closed this case in the month of xxxx, 2017.

Now both the parties **understood the essence of the life and also concerned about future of their son**. Both the parties agreed that they were failed to provide love and affection to their son since November, 2016. Both the parties realized the value of relation and family and they conveyed the same to their parents and elders.

Since last few months both the parties thought of re-join and re-build their matrimonial life and want to lead a happy married life. Both the parties assure/confirm that they shall not threat or warn each other & they shall not file any kind of false cases in the future. Both the parties want to lead a happy married life with their son.

Both the parties agreed that they shall fulfill their parental responsibilities to their son as a mother and a father.

NOW THIS M.O.U. WITNESSETH AS UNDER

- 1) The First Party and Second Party have decided to re-join and re-build their matrimonial life and live happily as a wife and husband immediately from this time onwards.
- 2) If there is any kind of issue/problem pertaining to matrimonial life from Second Party, First Party shall approach the elders/community members, without considering the elders/Community as per below witness list, First Party shall not proceed to any kind of legal battle against Second Party.
- 3) That the Second Party herein has agreed and accepted to re-join the matrimonial life with FIRST PARTY along with their son. And also Second

Party agreed that shall fulfill his responsibilities as a husband to First Party and as a father to their son.

- 4) Second Party assure/confirm that shall not file any kind of false cases in future.
- 5) First Party assure/confirm that shall not file any kind of false cases in future in ref. to dowry harassment & domestic violence against Second Party and in-laws.
- 6) That both the parties declare that they shall co-operate with each other to lead a happy married life with **“full consciousness, freely and under no duress & in sound mind & full senses & free from any kind of pressure & fully understand what is right and wrong. With their free will, without any force or compulsions from parents & others”**.
- 7) That both the parties agreed in the presence of elders and well-wishers that **“to re-join and re-build their matrimonial life and live happily as wife and husband immediately from this time onwards”**.
- 8) **Under any circumstances, after joining the matrimonial life by both the parties, if there is any kind of disputes arose between FIRST PARTY & SECOND PARTY, they shall approach family counselling centers.**
- 9) **That both the parties shall abide by the conditions mentioned above and if any of the party violates any condition then they shall be prosecuted as per law.**

In witness whereof, both the parties scribed their signatures on Deed of Matrimonial re-join with mutual consent with their own free will and consent without any coercion or undue influence on this the day, month and year as aforementioned in the presence of below witness.
